"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **in Greenville Township, situate on the southeastern side of Shubuta Drive, being shown and designated as Lot 86 on plat of Farmington Acres recorded in Plat Book RR at pages 106 and 107 and having according to said plat the following metes and bounds, to-wit:**

**BEGINNING at an iron pin on the southeastern side of Shubuta Drive at the joint front corner of Lots 85 and 86 and running thence with the line of Lot 85 S. 37-15 E. 150 feet to pin; thence N. 52-45 E. 90 feet to pin; thence N. 37-15 W. 150 feet to pin on Shubuta Drive; thence with the southeastern side of Shubuta Drive, S. 52-45 W. 90 feet to the point of beginning.**
