All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Buncombe Street, in the City of Greer, and being known and designated as lot no. Seven (7) of the Marion E. Wooten property as shown on plat prepared by H. S. Brockman, Reg. Surveyor, dated Jan. 6, 1959 and which plat has been recorded in the R. M. C. Office for said County in Plat Book 00, page 217, and having the following courses and distances, to-wit: Beginning at an Iron Pin on the North side of Buncombe Street at the joint front corner of lots nos. 6 and 7 as shown on said plat, and running thence with the joint property line of said two lots N.7-03 W.173.8 feet to an Iron Pin, thence S.76-45 W.52.9 feet to an old Pin, thence S.14-38 W.183 feet to an old Pin on North side of said street, thence with the North side of said street N.82-09 E.120 feet to the beginning point.
