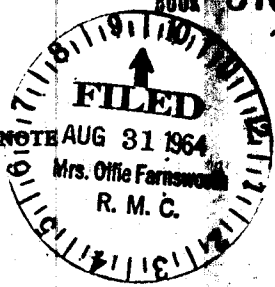

MORTGAGE REAL ESTATE TO SECURE NOTE

THIS MORTGAGE made this 23rd day of January, 1964, between
James W. Ferguson and Lola Mae Ferguson, herein called "Mortgagors,"
of Greenville South Carolina and Albert M. Finley Contracting
Co. Greenville South Carolina, herein called "Mortgagee," a South Carolina corporation.

WITNESSETH:

1. Mortgagors are justly indebted unto Mortgagee in the amount of \$3,469.20, payable in 60 equal
successive monthly installments of \$57.82 each, as evidenced by Mortgagors' Promissory Note of even date.

2. Mortgagors for, and in consideration of said debt and sum of money aforesaid, and for the better securing the payment
thereof to Mortgagee according to the terms of said Promissory Note and also in the consideration of the further sum of
THREE DOLLARS to Mortgagors in hand well and truly paid by Mortgagee at and before the sealing and delivery of these
presents (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released and by these presents do
hereby grant, bargain, sell and release unto Mortgagee the following described real estate located in
Greenville County, South Carolina.

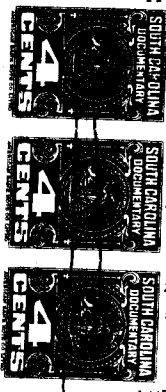
All that piece, parcel or lot of land in Butler Township,
Greenville County, State of South Carolina, about four miles
east of the Greenville County Court House, on the southern
side of a County Road, a top soil road leading westerly off the Congaree
Road, and according to a survey made by J. Mac Richardson, R. L. S.,
in March 1957, having the following metes and bounds, to-wit:

Beginning at a point, iron pin, at a bend in said County Road
joint corner with property of John Henry Walker, and running thence
N. 64-47 E. 60 feet along said County Road to a point, iron pin,
joint corner with property of Grantor: (See other sheet)

TOGETHER with all buildings, improvements, fixtures or appurtenances now or hereafter erected thereon, including all
apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air
conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window
blinds, storm doors and windows, screen doors, awnings, stoves and water heaters (all of which are declared to be a part of
said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD all and singular the said Premises unto the said Mortgagee, its successors, heirs, and
assigns forever.

3. Mortgagors do hereby warrant and will forever defend the said Premises unto Mortgagee from and against Mortgagors,
Mortgagors' heirs, executors, administrators, and assigns and all persons whomsoever lawfully claiming or to claim the same
any part thereof.
