NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township and lying on the west side of the Greer and Gowansville road, joined on the South by Clayton land and on the North and West by A. J. Neves and on the east by the above said road. Having the following metes and bounds, courses and distances:

Beginning on an iron pin in said road, thence with said road as the line North 17° 45min. east 250 feet to a pin in said road; thence North 86° 35 min. west 288 feet to an iron pin; thence north 40° 25 min. west 298 feet to an iron pin; thence north 68° 35 min. west 206 feet to an iron pin; thence south 10° 25 min. west 545 feet to an iron pin on the Clayton line; thence with the said Clayton line 87° .05 min. east 690 feet to an iron pin in the above said road at the beginning corner, containing 5.85 acres, more or less.

The above property is the same property this day conveyed to us by Angell S. Robinson, Marceda S. McGinn, and Veda S. Nevin by deed of even date herewith to be recorded.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
