We, Ronald F. Hice, Sr., and Lavonia E. Hice SEND GREETING:

WHEREAS, we the said Ronald F. Hice, Sr., and Lavonia E. Hice
in and by our certain promissory note in writing of even date with these Presents, are well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
Nine thousand five hundred and no/100 - - (\$9,500.00) Dollars,
with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of

One hundred twenty and 39/100 - - - (\$ 120.39) Dollars

BEGINNING at an iron pin at old S. Oak in woods, and running thence with old line N. 45-15
W., 727.5 feet to stake on road bank, old corner; thence with said bank S. 59-15 W., 50
feet to stake; thence S. 45-15 E., 200 feet to stake; thence S. 59-15 W., 150 feet to
stake; thence S. 45-15 E., 523 ft. to stake in old line at back; thence with said old
line N. 60-45 E., 200 feet to pin and beginning corner, containing 2.64 acres more or
