WE, MARVIN E. HAYGOOD and JEAN Z. HAYGOOD of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation
organized and existing under the laws of the State of North Carolina, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which

and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

ALL that lot of land with improvements situate at the northeastern intersection of
Collinwood Lane with Brushy Creek Road in Greenville County, South Carolina,
being shown and designated as Lot No. 1 on a Plat of the Subdivision of COLLIN-
WOOD PARK made by J. C. Hill, Surveyor, dated October 1962 and recorded in
the R. M. C. Office for Greenville County, South Carolina, in Plat Book CCC, Page
27, reference to which is hereby craved.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and
assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple
absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the

the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
