All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the north side of Benjamin Avenue about one mile southward from the City of Greer, in Chick Springs Township, and being Lot No. 19 in Brookhaven, property of the Dobson Estates according to survey and plat by H. S. Brockman, Registered Surveyor, dated December 12, 1957, amended September 1, 1959, recorded in the R. M. C. Office for Greenville County in Plat Book RR, page 41, and having the following courses and distances, to-wit: Beginning at an iron pin on the north side of Benjamin Avenue, corner of Lots Nos. 18 and 19, and running thence along the line of said lots, N.10-55 E.170 feet to an iron pin, rear corner of Lot No. 11; thence along the line of Lot No. 11, N.79-25 W.100 feet to an iron pin, corner of Lot No. 20; thence along the line of Lot No. 20, S.10-55 W.170 feet to an iron pin on the north side of Benjamin Avenue; thence along said Avenue, S.79-25 E.100 feet to the beginning corner.
