"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being shown and designated as Lot 14 on plat of land of Pride & Patton Land Company recorded in Plat Book E at page 249 and having, according to said plat, the following metes and bounds, to-wit:
