All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 10 on plat of property of Harry H. Palm recorded in plat book B at page 84 of the RMC Office for Greenville County, S. C., said lot having a frontage of 57.5 feet on the north side of Brunswick Avenue, formerly Milton Avenue, having a depth of 220.7 feet on the west side, a depth of 210.8 feet on the east side, and a rear width of 59.9 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
