TO ALL WHOM THESE PRESENTS MAY CONCERN: I, F.W. Lewis

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

SIXTEEN THOUSAND FIVE HUNDRED

DOLLARS (\$ 16,500.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, near the City of Greer and northeast therefrom, being all of Lot No. 18 as shown on a plat of subdivision known as FOREST HILLS made for the Greer Post of the American Legion by J.Q. Bruce, Surveyor, dated October, 1955, recorded in the R.M.C. Office for Greenville County in Plat Book VV, at page 59, reference to said plat and record thereof being expressly made for a complete and detailed description of said lot.

This is the identical property as conveyed to the mortgagor by Bobby R. Satterfield by deed of even date and to be recorded herewith.
