any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become

a subdivision known as Sans Souci, and being known and designated as Lot No.

recorded in the RMC Office for Greenville County in Plat Book A, at page 396,
and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Chandler Street at the joint
corner of Lots 96 and 97, which point is 350 feet north from the northeast
corner of the intersection of Martin Street and Chandler Street, and running
