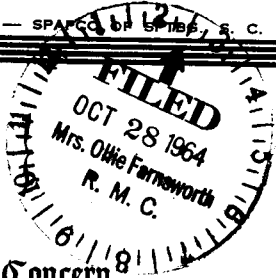

**To all whom these Presents may Concern.**

I, Delsia P. Barnes, hereinafter called Mortgagor, SEND GREETING:

Whereas, I, the said Mortgagor, Delsia P. Barnes,  
 in and by my certain promissory note in writing, of even date with these

Presents, am well and truly indebted to The Commercial National Bank of  
 Spartanburg, hereinafter called Mortgagee,

in the full and just sum of THREE THOUSAND, SEVEN HUNDRED, FIFTY AND NO/100  
 (\$3,750.00) DOLLARS, principal and interest  
 , to be paid

in ninety-six (96) equal, consecutive, monthly installments of Forty-  
 nine and 29/100 (\$49.29) Dollars each, the first such installment to  
 be due and payable one (1) month from the date hereof,

, with interest thereon from date

at the rate of 6% per centum per annum, to be computed and paid as above stated

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
 the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
 sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands  
 of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof neces-  
 sary for the protection of his interests to place and the holder should place the said note or this mortgage in
