(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwest side of Henderson Circle, about 1 mile Southwest of the City of Greer, in Chick Springs Township, and being known and designated as lot no. One (1) of the T. A. Long property as shown on plat prepared by Madison H. Woodward, dated Aug. 17, 1963 and which plat will be recorded forthwith in the R. M. C. Office for said County, and having the following courses and distances, to-wit: Beginning at an Iron Pin on the Southwest side of Henderson Circle at the joint front corner of lots nos. 1 and 2 as shown on said plat, and running thence with the Southwest side of Henderson Circle S.45 E.90 feet to an Iron Pin, thence S.47-15 W.200 feet to an Iron Pin, thence N.45 W.90 feet to an Iron Pin at the joint rear corner of said lots nos. 1 and 2, thence with the joint property line of said two lots N.47-15 E.200 feet to the beginning point.
