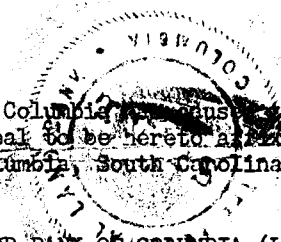

A S S I G N M E N T  
(Loan No. S- 171-385)

FOR value received, The Federal Land Bank of Columbia, the owner and holder of the note and mortgage hereinafter described, without recourse on itself, and without recourse on any national farm loan association\* and without warranty of any kind or nature, express or implied, does hereby transfer, set over and assign to **T. B. Butler, his heirs** -----, and assigns, that certain mortgage from **John Henry Perkins** ----- to The Federal Land Bank of Columbia, dated **March 29, 1950**, and recorded in the public records of **Greenville** County, South Carolina, in Book **455**, at pages **190-193** and the indebtedness secured thereby which is evidenced by an amortization note of the same date, except that neither the stock issued by The Federal Land Bank of Columbia or by any national farm loan association in connection with this loan, nor any interest in said stock or proceeds thereof, is assigned. If the contract rate of interest stated in the note and mortgage hereby assigned is higher than **4 1/2** per centum per annum, this assignment is subject to reduction of said contract rate of interest to **4 1/2** per centum per annum, heretofore made by assignor, for all interest, except default interest, payable on installment dates occurring after June 30, 1944.

It is understood that the instrument assigned and/or the lien securing it is subject to subordination and nondisturbance, and proration of crop proceeds, agreements, if any, executed by the undersigned in favor of any other lender.
