All that lot of land in the county of Greenville, state of South Carolina, at the southeast corner of Florida Avenue and Carl Court, being known and designated as Lot No. 1, on plat of Carl Court subdivision recorded in plat book KK page 149, of the RMC Office for Greenville County, S. C.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
