securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land in the County of Greenville,
State of South Carolina, known and designated as LOT NO. 4 on plat of
property of JACK O. CAMPBELL as recorded in Plat Book SS, at
Page 18, R.M.C. Office for Greenville County. Said lot having
a frontage of 70 feet on the Northeastern side of McClain Street
(NOW KNOWN AS McLEAN STREET) and a parallel depth of 175 feet and
a rear width of 70 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
