MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, C. C. Davis, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Ten Thousand and No/100-----(\$10,000.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of One Hundred Eleven and 03/100-----(\$ 111.03.) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable. 10 years after date; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of

All that errain piece. parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of Old U. S. Highway 29, near the City of Greenville, being known and designated as Lots Nos. 6, 7, and 8 on plat of property entitled "Property of Maggie Mae Lampe", recorded in the R. M. C. Office for Greenville County in Plat Book II, at Page 183, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of U. S. Highway No. 29 at the joint front corner of Lots 5 and 6, and running thence with the joint line of said lots, S. 84-52 W. 115.6 feet to an iron pin on the eastern edge of the right-of-way of the C. & G Division of Southern Railway; and running thence with the eastern edge of said right-of-way along the rear lines of Lots 6, 7, and 8, the following courses and distances: S. 14-25 E. 75.1 feet to an iron pin, S. 12-58 E. 80.1 feet to an iron pin, S. 11-58 E. 90 feet to an iron pin at the joint rear corner of Lots 8 and 9; thence with the joint line of said lots, N. 84-52 E. 66 feet to an iron pin on the western side of U. S. Highway No. 29, joint front corner of Lots 8 and 9; thence with the western side of said U. S. Highway No. 29, the following courses and distances: N. 3-08 W. 90 feet to an iron pin, N. 0-08 W. 155 feet to the point of beginning; being the same conveyed to me by Maggie Mae Gancedo by deed dated August 8, 1963, and recorded in the R.
