All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 166, Map 5 of Sans Souci Heights subdivision, recorded in plat book BB pages 90-91 of the RMC Office for Greenville County, S. C., said lot having a frontage of 70.8 feet on the north side of Langston Drive, a depth of 197.2 feet on the west side, a depth of 208 feet on the east side, and a rear width of 70 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
