"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Waddell Road, near the City of Greenville, being shown as Lot No. 42 on a plat of Section III of Wade Hampton Gardens recorded in Plat Book YY, Page 179, and described as follows:

BEGINNING at an iron pin on the eastern side of Waddell Road at the corner of Lot No. 43 and running thence with the eastern side of said Road, S. 13-11 W. 82.6 feet and S. 5-26 W. 27.4 feet to an iron pin at the corner of Lot No. 41; thence with the line of said lot, S. 82-59 E. 168.4 feet to an iron pin in the line of Lot No. 63; thence with the line of Lot Nos. 63 and 62 N. 9-52 E. 100 feet to an iron pin at the corner of Lot No. 43; thence with the line of said lot N. 79-36 W. 165.5 feet to the beginning corner.
