Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that certain piece, parcel and lot of land situate, lying and
being in the County of Greenville, State of South Carolina, known
and designated as Lot 40 as shown on a plat entitled Belle Meade
Subdivision, said plat being recorded in the R.M.C. office for
Greenville County in Plat Book "EE", at Pages 116 and 117. The lot
size is 70 X 39.6 X 34 X 60 X 117.3 X 115.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

assigns forever.
