"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, about three miles north from Greer and near Mosteller Mill, being shown as Tract No. 3 on a plat of the property of J.D. Atkins made by J.Q. Bruce, Registered Surveyor, dated September 20, 1954, and recorded in Plat Book II, page 188, R.M.C. Office for Greenville County. This tract contains approximately three acres of the southern portion of Tract No. 9 as shown on plat recorded in Plat Book FF, page 233, R.M.C. Office for Greenville County.
