RELEASE AND CANCELLATION OF SECURITY INSTRUMENTS

KNOW ALL MEN BY THESE PRESENTS, that SMALL BUSINESS ADMINISTRATION, an Agency of the United States pursuant to the Small Business Act (15 U.S.C. 631) is the holder and owner of one certain promissory note dated May 25, 1961, in the original amount of THREE HUNDRED NINETY THOUSAND AND NO/100 DOLLARS (\$390,000.00) executed and delivered by WELDING GAS PRODUCTS COMPANY, A Corporation, Chattanooga, Tennessee, to the order of Small Business Administration; said Note is secured by, among other things, the following security instruments:

Affidavit of Renewal of Chattel Mortgage dated April 24, 1964, and recorded in Book 435, page 47, in the Office of the R.M.C. for Greenville County, South Carolina.

Affidavit of Renewal of Chattel Mortgage dated April 24, 1964, and recorded in Book 865, page 179, Clerk of Court of Common Pleas and General Sessions, Richland County, South Carolina.

Notice of Assignment of Accounts Receivable to Small Business Administration executed jointly by Welding Gas Products Company on July 20, 1961, and by National Welders Supply Company, Inc., on July 24, 1961; recorded July 24, 1961, in Chattel Mortgage Book 678, page 275, Office of Clerk, Court of Common Pleas and General Sessions for Richland County, South Carolina.

WHEREAS the aforesaid Note having been paid in full, Small Business Administration desires to release its lien under said Mortgage and Notice of Assignment of Accounts Receivable.
