(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Belton Avenue (formerly Bennett Avenue) and the west side of Lanford Street in the City of Greer, Chick Springs Township, and being the east portions of Lots Nos. 41 and 42 of the property of D. S. Waddell according to survey and plat by H. S. Brockman, Reg. Surveyor, dated June 5, 1942 and amended by John A. Simmons, Reg. Surveyor, on August 23, 1962, and having the following courses and distances, to-wit: Beginning at the intersection of Lanford Street and Belton Ave., and running thence along the South side of Belton Ave. N.52-40 W.148 feet to an iron pin, new corner; thence a new line, S.16-10 W.143.7 feet to an iron pin on the line of Lot No. 40; thence along the line of said lot S.69-50 E.134.8 feet to an iron pin on the west side of Lanford Street; thence along Lanford Street N.18-35 E.99.3 feet to the beginning corner. And being the same property which was conveyed to mortgagor herein by Elmer S. Wilson by deed which will be recorded forthwith in the said office.
