To All Whom These Presents May Concern:

I, James Larry Goodson - - - - - hereinafter called
the Mortgagor(s), SEND GREETING:

C. Smith according to survey and plat by H.S. Brockman, R.S. dated May 25, 1936, and recorded in Plat Book T at Page 10, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:

BEGINNING at an iron pin on the south side of Carey Avenue, corner of lots Nos. 25 and 27, and running thence along the line of said lots S. 20-44 W. 158 feet to an iron pin; thence, S. 69-37 E. 113 feet to an iron pin, thence N. 1-30 E. 165 feet to the southside of Carey Avenue; thence along said Avenue, N. 69-25 W. 57.7 feet to the beginning corner.
