NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Saluda Dam Road, in Greenville Township, being shown as a major portion of tract 5 on plat of the property of R. A. Means, recorded in Plat Book H at page 144 and also being shown as tract 3.1, block 2, page B-14 of the County Block Book and more particularly described as follows:

BEGINNING at a stake on the Southern side of White Horse Road, corner of property now or formerly owned by Alice M. Moore and running thence S. 35½ W. 706.8 feet to a pin; thence S. 48-3/4 E. 435.6 feet to a pin; thence S. 49-3/4 E. 84.4 feet to a pin; thence N. 35-3/4 E. 411 feet to a pin; thence N. 72-40 W. 44 feet to a pin; thence N. 26-45 E. 439.6 feet to a pin on Saluda Dam Road; thence with the Southern side of said road, N. 70 W. 411.9 feet to the point of Beginning.
