a corporation organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Nine Thousand Three Hundred and No/100-- Dollars (\$ 9,300.00), with interest from date at the rate of five & one-fourth per centum (5 1/4%) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, S. C., or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Fifty One and 36/100 Dollars (\$ 51.36), commencing on the first day of April, 19 65, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of March, 19 95.

C. on the eastern side of South Washington Avenue and being known and designated as Lot No. 33 on plat of property of Nona Harris Squires recorded in the R. M. C. Office for Greenville County in Plat Book "S", at Page 151, said lot fronting 67 feet on the eastern side of South Washington Avenue and running back in parallel lines to a depth of 200 feet and being 67 feet across the rear.
