TO ALL WHOM THESE PRESENTS MAY CONCERN: Albert J. McDermid

(hereinafter referred to as Mortgagor) SENDS GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers, Nest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----

Sixteen Hundred Twenty and No/100 ----- DOLLARS (\$1,020.00),
 with interest thereon from date at the rate of 7 per centum per annum, said principal and interest to be repaid:

Payable \$45.00 on March 15, 1965 and a like payment of \$45.00 on the 15th day of each month thereafter until paid in full, with interest thereon from date at the rate of 7% per annum, to be computed and paid semi-annually in advance.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being a portion of Boyce's Addition to Greenville and being known and designated as Lot No. 42, Block D according to survey of W.A. Adams, recorded in Plat Book A at Page 383, and described as follows:

BEGINNING at an iron pin on the south side of East Washington Road, joint corner with Lots Nos. 41 and 42, and running thence in a southerly direction 175 feet to an iron pin on Boyce Spring Avenue; thence in an easterly direction along said Avenue 50 feet to an iron pin, joint corner with Lots 42 and 43; thence in a northerly direction 175 feet to pin on East Washington Road; thence in a westerly direction along said Road 50 feet to the beginning."

Being the same property conveyed to the mortgagor by deed recorded in Deed Book 72 at Page 116.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
