SEND GREETING:

Whereas, I, the said Frank P. Hammond

percentum per annum, to be computed and paid until paid in full; all interest not paid when due to bear

And if any portion of principal or interest be at any time past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole amount evidenced by said note to become immediately due at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including ten (10%) per cent, of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

BEGINNING at an iron pin on the West side of Hialeah Road at the joint front corner of Lots 334 and 335 and runs thence along the line of Lot 334, N. 76-41 W., 175 feet to an iron pin; thence N. 13-19 E., 100 feet to an iron pin; thence with the line of Lot 336, S. 76-41 E., 175 feet to an iron pin on the West side of Hialeah Road; thence along Hialeah Road S. 13-19 W., 100 feet to the beginning corner.
