(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. Seven (7) of a subdivision known as Glendale Heights Addition as shown on a plat prepared by J. Mac Richardson, Engineer, June 16, 1958 and recorded in the R. M. C. Office for said County in Plat Book 2Q, page 13 and having according to said plat the following metes and bounds, to-wit: Beginning at an iron pin on the western side of Freestone Street which pin is 210 feet south of the intersection of said street with Dresden Avenue and running thence with the western side of Freestone Street S.6-45 E.70 feet to an iron pin front corner of Lot No. 6; thence with the line of said lot S.83-15 W.140 feet to an iron pin at the rear corner of Lot No. 12; thence with the line of said lot N.6-45 W.70 feet to an iron pin at the rear corner of Lot No. 8; thence with the line of said lot N.83-15 E.140 feet to the beginning corner.
