We, JACK E. ANTHONY and JEANETTE M. ANTHONY of Greenville, South Carolina, hereinafter called the Mortgagor, send (s) greetings:

ALL that lot of land with the buildings and improvements thereon situate on the West side of Underwood Avenue in the City of Greenville in Greenville County, South Carolina, being shown as Lot No. 53 on plat of Glenn Grove Park, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book F, at Pages 232 and 233, said lot fronting 50 feet along the West side of Underwood Avenue, running back to a depth of 150 feet on the South side, to a depth of 150 feet on the North side, and being 50 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
