(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the southern side of Walker Road in the Rocky Creek Church Community, Butler Township, and having the following metes and bounds.

BEGINNING at a point near the center of Walker Road at the corner of property of D. V. Feaster and running thence along said Road N. 66-20 E. 147 feet to a point at the corner of property of Billy D. Chandler; thence along the Chandler line and the line of C. B. Jones S. 25-50 E. 310 feet to the line of property of C. B.
