All that lot of land with the building and improvements thereon, situate on the East side of Williamsburg Drive near the City of Greenville, Greenville County, South Carolina, being shown as lot number 3 on a plat of section 1 and 2 of Belle Meade subdivision made by Piedmont Engineering Service June 1954 recorded in the R.M.C. Office for Greenville County in plat book EE at pages 116 and 117.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
