DOLLARS (\$ 10,000.00), with interest thereon from date at the rate of Six ~~XXXXXX~~ per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, Town of Simpsonville, on the south side of East Curtis Street and being shown and designated as Lot No. 1 on a plat of Eastview Heights, prepared by C. O. Riddle, surveyor, dated June, 1958, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book 00, at Page 144, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of East Curtis Street at the joint front corner of Lots 1 and 2 and running thence along the line of Lot 2 S. 8-13 E. 277.5 feet to an iron pin; thence N. 79-42 E. 105 feet to and iron pin at the rear corner of Lot 1 and property now or formerly of G. D. Tumblin; thence along the line of Lot 1 N. 8-13 W. 276 feet to an iron pin on the south side of East Curtis Street; thence along the south side of East Curtis Street S. 77-43 E. 105.3 feet to the beginning corner.
