WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Seven Thousand, Two Hundred and 00/100

DOLLARS (\$ 7,200.00), with interest thereon from date at the rate of Six and one-half per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and shown as Lot No. 11 and Lot No. 11-A on a revised map of Franklin Hills, Section No. 1, recorded in the R.M.C. Office for Greenville County in Plat Book DDD, at page 95, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on a County Road as shown on said plat at the joint corner of Lots 10 and 11-A, and running thence along said lot, S. 62-16 W. 90 feet to the joint front corner of Lots 11 and 12; thence along the joint line of said lots, N. 27-44 W. 180.9 feet to an iron pin; thence N. 66-53 E. 90.3 feet to the rear joint corner of Lots 10 and 11-A; thence with the line of said lot, S. 27-44 E. 173.5 feet to an iron pin at the point of beginning.
