ALL that lot of land with improvements lying on the northwestern side of Edgewood Drive in Greenville County, South Carolina, being shown as Lot No. 59 on a Plat of KIRKWOOD HEIGHTS made by Pickell & Pickell, Engineers, dated October, 1954, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book EE, Pages 110 and 111, reference to which is hereby craved. This property faces on the northwestern side of Edgewood Drive for a distance of 70 feet and runs back for a depth of 169 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
