--WE, CHARLES B. JENKINSON AND GEORGIA L. JENKINSON of

commencing on the first day of June, 19 65 and on the first day of each month thereafter
until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of May, 19 95

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land with improvements thereon
situate, lying and being in Greenville County, State of South Carolina,
being known and designated as LOT NO. 28 on plat of WILLIAM M. EDWARDS,
recorded in the R.M.C. Office for Greenville County in Plat Book S,
at Page 12. Said lot having a frontage on the Northeastern side of
Elaine Avenue of 133.4 feet; a depth on the Northern side of 247.4 feet;
a depth on the Southern side of 242.4 feet and a width across the rear
of 151.55 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
