All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Greenville Township, near the Corporate limits of the City of Greenville, County of Greenville, State of South Carolina, in Tax District No. 235, and being known and designated as Lot No. 154 of a Subdivision of the Village of Mills Mill as shown on a plat thereof made by Piedmont Engineering Service, dated June, 1954, and recorded in the R.M.C.
