(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 121 on plat of Property of Central Development Corp., recorded in Plat Book BB at Pages 22-23 in the Office of the R.M.C. for Greenville County, and having according to said plat the following metes and bounds, to wit:

"BEGINNING at an iron pin on the southern side of Dellwood Drive, at the joint front corner of Lots Nos. 122 and 121, and running thence with the line of Lot No. 122, S. 12-53 W. 191.2 feet to an iron pin; thence N. 73-02 W. 102.8 feet to an iron pin in line of Lot No. 119; thence with line of Lot No. 119, N. 17-01 E. 30.4 feet to an iron pin; thence with line of Lot No. 120, N. 20-20 E. 157.2 feet to an iron pin on Dellwood Drive; thence with said Dellwood Drive S. 75-28 E. 80 feet to the point of beginning."
