BOBBY R. PRESSLEY AND MARGARET M. PRESSLEY of
Greenville County, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

CAMERON-BROWN COMPANY

, a corporation
organized and existing under the laws of North Carolina , hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which

commencing on the first day of August , 19 65 , and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of July , 1995.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina: on the southeastern side of Kentland Lane and being known
and designated as Lot No. 33 of Kentland Park as shown on plat thereof recorded in
the R. M. C. Office for Greenville County in Plat Book "XX", at Pages 45 and 46,
and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Kentland Lane at the joint
front corner of Lots Nos. 32 and 33 and running thence along said Lane N. 26-45
E. 67.9 feet to an iron pin; thence along the joint line of Lots Nos. 33 and 34, S.
59-38 E. 202.8 feet to an iron pin; thence S. 22-15 W. 74.7 feet to an iron pin;

assigns forever.

absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the

the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
