TO ALL WHOM THESE PRESENTS MAY CONCERN: **Bates & Cannon, Inc.**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Ten Thousand and No/100** ----- DOLLARS (\$ 10,000.00), with interest thereon at the rate of **Six** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **20** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in **Paris Mountain Township** shown as the greater portion of Lot No. 22 on a plat entitled **Addition to Highview Acres** recorded in Plat Book GG at Page 122 and also shown on plat showing Revision of Lots 22 and 21 Highview Acres recorded in Plat Book III at Page 168 and having according to the latter plat the following metes and bounds:

BEGINNING at an iron pin on Arlene Drive at revised front corner of Lot No. 21; thence with said drive S. 78-49 E. 69.3 feet to an iron pin on Arlene Drive; thence continuing with said drive S. 84-30 E. 10 feet to an iron pin at rear corner of Lot No. 23; thence with rear line of Lot 23 and 24 S. 5-30 W. 165 feet to an iron pin; thence N. 84-30 W. 80 feet to an iron pin at rear corner of Lot No. 21; thence with revised line of Lot No. 21 N. 5-50 E. 171.9 feet to beginning corner.
