Williams in consideration of the said debt and sum of money
aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and
also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
Ruth C. Garrison Bishop, her heirs and assigns:

ALL that piece, parcel or lot of land in Greenville Township, Greenville
County, South Carolina, on the east side of McDade Street, and being
known and designated as Lot No. 106, of Block B, of a subdivision known
as City View, as shown on a plat thereof recorded in the R. M. C. Office
for Greenville County in Plat Book A, Page 461, and having the following
metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of McDade Street at the joint
corner of Lots Nos. 105 and 106, of Block B, which point is 250 feet north
of the northeast corner of the intersection of McDade Street with O'Neal
Street; and running thence along the line of Lots 105 and 106, S. 89 1/2
E. 150 feet to an iron pin on an alley; thence N. 1/2 E. 50 feet to an iron
