And the Mortgagor hereby assigns, sets over and transfers unto the said THE PERPETUAL BUILDING AND LOAN ASSOCIATION OF ANDERSON, its successors and assigns, all the rents and profits accruing from the premises hereinabove described, retaining, however, the right to collect said rents so long as the payments herein set out are not more than thirty days in arrears, but if at any time any part of said debt, interest premiums or taxes shall be past due and unpaid, said Mortgagee may (provided the premises herein described are occupied by a tenant or tenants), without further proceedings, take over the property herein described, and collect said rents and profits and apply same to the payment of taxes, insurance, interest and principal, without liability to account for anything more than the rents and profits actually collected, less the costs of collection; and should said premises be occupied by the Mortgagor herein, and the payments hereinabove set out become past due and unpaid, then the Mortgagor hereby agrees that said Mortgagee, its successors and assigns, may apply to any Judge of the Circuit Court of said State, at Chambers or otherwise, for the appointment of a Receiver, with authority to take charge of the mortgaged premises of collection) upon said debt, interest, taxes and insurance, without liability to account for anything more than the rents and profits actually collected.

PROVIDED, ALWAYS, nevertheless, that if the said Mortgagor shall pay or cause to be paid to THE PERPETUAL BUILDING AND LOAN ASSOCIATION OF ANDERSON, its successors or assigns, said debt, and all interest and amounts due thereon, then this deed of bargain and sale shall become null and void; otherwise to remain in full force and virtue.

And it is further agreed by and between the said parties hereto, that the said Mortgagor is to hold and enjoy the said premises until default of payment shall be made.
