west side of South Estate Drive, in Gantt Township, Greenville County,
State of South Carolina, shown as Lot 19 on plat of subdivision known a
Crestwood, made by J. C. Hill, Surveyor, February 28, 1949, recorded in
the RMC Office for Greenville County, South Carolina, in Plat Book "S",
at page 189.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.
