JACK E. SHAW BUILDERS, INC. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand and No/100ths-----

DOLLARS (\$ 6,000.00), with interest thereon from date at the rate of six----- per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northwestern side of Langley Drive in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 25 and a portion of Lot No. 24 as shown on a plat of Langley Heights, prepared by Dalton & Neves, dated June, 1937, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book N at page 133, and having according to a more recent plat prepared by R.E. Dalton, dated August, 1947, entitled "Property of Bill Ashley Jordan", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KKK at page 53, the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Langley Drive at the joint front corner of Lots Nos. 25 and 26, and running thence with the line of Lot No. 26 N. 31-37 W. 168.3 feet to an iron pin on the Southeastern side of a 15 foot alley; thence with the Southeastern side of said alley S. 46-47 W. 51.1 feet to an iron pin at the joint rear corner of Lots Nos. 24 and 25; thence a new line through Lot No. 24 S. 27-49 E. 118.9 feet to an iron pin; thence continuing a new line through Lot No. 24 S. 43-34 E. 40.1 feet to an iron pin on the Northwestern side of Langley Drive and at the joint front corner of Lots Nos. 24 and 25; thence with the Northwestern side of Langley Drive N. 58-23 E. 50 feet to the point of beginning.
