TO ALL WHOM THESE PRESENTS MAY CONCERN: Keith J. Marquis and Ellie D. Marquis

of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being on the northern side of Newcastle Way, near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as all of Lot No. 56 and adjoining portion of Lot No. 55 of s subdivision known as Wellington Green, No. 2, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book HHH at Page 107; said property is also shown as the property of Keith J. Marquis and Ellie D. Marquis by plat recorded in the R.M.C.
