NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying being, and situate in Chick Springs Township, Greenville County, South Carolina, on the west side of State Park Road (sometimes known as Mt. Creek Road and also S. C. Highway No. 253) and bounded by lands of, now or formerly, V. V. McCarter, Ben H. Scott, et al., and containing 0.48 acres, more or less, and having according to a recent survey made by R. K. Campbell and H. C. Clarkson, Jr., dated July 30, 1965, entitled property of Ralph R. Knight and Lillian M. Knight, recorded in the RMC Office for Greenville County, S. C., in Plat Book KKK, Page 81, the following metes and bounds, to wit:

BEGINNING at an iron pin on the west side of State Park Road at the joint corner of the property herein being mortgaged and property of, now or formerly, Ben H. Scott and runs thence along said Scott Property line, S. 77-15 W., 210.5 feet to an iron pin; thence S. 10-30 E., 95 feet to an iron pin; thence N. 77-15 E., 226 feet to an iron pin on the west side of State Park Road; thence along State Park Road, N. 18-20 W., 96 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever.
