That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the northwest side of Woodville Avenue and being known and designated as Lot No. 132 of a subdivision known as "Overbrook" as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "F", at Page 218 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Woodville Avenue at the corner of Lot No. 133, which point is 93 feet east from the intersection of Jedwood Drive and running thence along the line of Lot No. 133 N. 8-41 W. 153.7 feet to an iron pin at the rear corner of said lot; thence N. 82-14 E. 40 feet to an iron pin at the rear corner of Lot No. 131; thence along the line of that lot S. 20-09 E. 150 feet to an iron pin on the northwest side of Woodville Avenue; thence along the line of said Woodville Avenue S. 76-15 W. 70 feet to the beginning corner.
