TO ALL WHOM THESE PRESENTS MAY CONCERN: Rita B. Ouellette

Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Cameron Brown Company

of five and one-fourth per centum ( 5 1/4 %) per annum until paid, said prin-

or at such other place as the holder of the note may designate in writing, in monthly installments of  
Sixty-Two and 77/100 - - - - - Dollars (\$ 62.77 ),  
commencing on the first day of October, 19 65, and on the first day of each month there-  
after until the principal and interest are fully paid, except that the final payment of principal and interest,  
if not sooner paid, shall be due and payable on the first day of September, 19 95

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better  
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that certain lot of land lying in the State of South Carolina,  
County of Greenville on the northwestern side of Kay Drive shown as  
Lot No. 118 on a plat of Belmont Heights, Section 2 recorded in the  
RMC Office for Greenville County in Plat Book GG at Page 99 and being  
further shown on a survey entitled Property of Rita B. Ouellette  
prepared by C. C. Jones, R. L. S. dated July 27, 1965 and having such  
metes and bounds as will appear by reference to the said plats and  
survey

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be  
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter  
attached to or used in connection with the real estate herein described.

assigns forever.
