"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 23 on Plat of Property of B. F. Reeves, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "OO", Page 191. Said lot fronts on the northerly side of Gary Avenue 80 feet, has a depth of 180 feet on the westerly side of Reeves Drive, a depth of 180 feet on the easterly side and is 80 feet across the rear.
