All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, in School District 519, on the east side of Carolina Avenue, and being known and designated as Lot No. 3 of Block J of Section #5, of a subdivision known as "East Highlands Estates" as shown on plat by Dalton & Neves, Engineers, in February 1941, and recorded in Plat Book K, Page 80, and described as follows:
